AUTHORITY AND CERTIFICATIONS:

- I am commissioned by the chief of the City of Renton as a Renton Police Officer, authorized to enforce all laws in the State of Washington.

History:

I have been a commissioned law enforcement officer for nineteen years, employed by the City of Renton Police Department for nine of those years. I was previously a police officer with the City of North Las Vegas (NV). I am currently assigned as an investigator within the Renton Police Department Patrol Service Division.

My primary duties include investigating fatality and critical/serious injury collisions, any felony case involving animals and investigating hit and run collisions with the responsibility of preparing cases, where probable cause exists for prosecution.

I successfully completed the Lateral Law Enforcement Training through the Washington State Criminal Justice Training Commission. I have also completed the Law Enforcement Training with the Southern Nevada Law Enforcement Academy.

My certified training in the field of traffic collision investigation encompasses the following: Basic, Advance, Technical, Reconstruction and ARIDE (Advanced Roadside Impaired Driving Enforcement). I have additional training in DUI recognition and have a current BAC certification. I have also completed the Basic and Advanced Police Motorcycle Operator's Course in Nevada and in Washington State. I have completed continued training through the Renton Police Department. I have held previous assignments at the North Las Vegas PD in Internal Affairs as a Background Investigator, Traffic Investigator (motors) and in the Problem Solving Unit as a Criminal Gang Investigator.

a lunch event for Dunn Lumbar in Bellevue (WA) during the summer of 2017. During the event, Richards went up to Illian and asked if there was pineapple juice in the BBQ sauce. Illian said he answered immediately that there was none (pineapple juice) in the BBQ sauce. Illian said that he did not check because he was confident that there was none in the BBQ sauce.

Later on the day of the event, he received a call from Scott who was angry. She told Illian that she got sick because she ate his BBQ sauce which contained pineapple sauce. Illian went back to the sauce container and realized that there was pineapple sauce in the BBQ sauce. As I was talking to Illian, he was getting upset and blaming himself for making a mistake. Susan and Illian said they paid for Scott's medical bill associated with this allergic reaction and provided me a copy of the notes they took along with the check stub. The total amount they paid Scott was \$874.
